MINUTES

ATTENDANCE

Commissioners: Yvonne Lopez-Morton, Commission Chair; Deborah Lee; Shawn Murinko; Charlene Strong; and Vanessa Gaston (via telephone). A quorum was present.

Staff: Sharon Ortiz; Executive Director; Cheryl Strobert, Assistant Director; Tanya Calahan, Executive Assistant to the Commissioners; Idolina Reta, Civil Rights Specialist; Nick Aaseby, Fiscal Analyst; and Traci Friedl, Assistant Attorney General.

OPENING AND WELCOME

Commissioner Lopez-Morton called the meeting to order at 9:00 a.m.

MINUTES

Commissioner Murinko made a motion to approve the minutes for the March 31, 2011 meeting. Commissioner Gaston seconded the motion. Motion carried.

EXECUTIVE DIRECTORS REPORT

Sharon Ortiz reviewed the monthly agency report.

Nick Aaseby spoke about the agency's budget. He highlighted year to date expenditures and savings. He also shared information about the Senate's proposed operating budget and the impact on the agency.

CASE CLOSURES

Commissioner Murinko made a motion to approve case closures. Commissioner Strong seconded the motion. At the request of the Commissioners, Civil Rights Specialist Idolina Reta summarized the investigations and no reasonable cause findings for Ling v. WA State Office of Minority and Women's Business Enterprises (OMWBE) and Diaz v.

OMWBE. Although the ultimate findings were no reasonable cause, ethics issues came to light during the investigations. After discussion, the Commissioners directed staff to work with Chair Lopez-Morton on drafting a letter to the Executive Ethics Board expressing the ethical concerns revealed during the investigations with copies of the findings.

Motion to approve case closures carried.

COMMISSION MEETING SCHEDULE

The Commissioners have no meetings scheduled for the remainder of 2011. They discussed publishing a meeting calendar for the remainder of the year. Commissioner Gaston informed the Commissioners that she resigned her position as a Commissioner effective August 31, 2011.

After discussing specific dates and options for meetings, Commissioner Murinko made a motion to schedule the remaining meetings for 2011 on the last Friday of each month for the remainder of 2011 except the November meeting will be on November 18, 2011. Commissioner Lee seconded the motion. Motion carried.

Commissioner Gaston noted that she will be absent from the May 27, 2011 and June 24, 2011 meetings due scheduling conflicts. Commissioner Strong reported that she will be unable to attend the October 28, 2011 meeting.

COMMISSIONER ROLES AND PRIORITIES

Commissioner Morton asked that each Commissioner come back next month with individual answers to the following questions. What are the Commissioners' highest priorities? How do you see your role as a Commissioner? What do you want to accomplish as a Commissioner?

Commissioner Murinko suggested that the Commissioners discuss these items at the current meeting.

Commissioner Morton spoke first about making outreach a priority and holding at least two forums per year in cities such as Vancouver and Pasco. She suggested submitting Commissioner activities more formally to report to the Governor's Office.

Commissioner Gaston suggested that Commissioners focus on rulemaking and educating the public about what the agency can and can't do. She expressed that she encounters this issue in Clark County because the general public is not well informed about the agency's jurisdiction.

Commissioner Strong spoke about Commissioners conducting outreach in his or her own communities and having a greater presence. She's spoken at local schools resulting in

positive feedback. She suggested that each Commissioner recommit to his or her role as a Commissioner.

Commissioner Murinko suggested that the agency focus on correcting the definition of "service animal" in RCW 49.60 and engage in rulemaking for recently added protections under the law such as sexual orientation and gender identity discrimination. He spoke about the Commissioners reinventing their roles as leaders and accomplishing more at monthly meetings. What happened during the current Legislative session should be a wake up call. If a Commissioner can't commit to these things, he or she should rethink his or her appointment as a Commissioner.

Commissioner Lee expressed frustration. She pointed out that the Commissioners could have engaged in outreach and public forums all along during the budget crisis. Public forums don't have to be costly. She spoke about partnering with community and other civil rights organizations on outreach efforts. The Commission can do a better job of utilizing those established community partnerships to jointly conduct outreach.

Commissioner Lee mentioned that she's received feedback from the public who have expressed a desire for "Know Your Rights" kinds of forums. They are interested in learning what the agency does and how to navigate the resources available through other government agencies, which can be bureaucratic.

CASE APPROVAL DELEGATION

Commissioner Murinko spoke about efficiencies and recommended that the Commissioners delegate case approval authority to the Executive Director. The Commissioners then discussed whether this is feasible. Commissioner Lee expressed concerns about not having Commissioner oversight for case approval. Commissioner Murinko then made a motion to delegate case finding approval authority to the Executive Director for a 90 day trial period. The Commissioners directed staff to develop procedures for this new case closures process. Commissioner Gaston seconded the motion. Commissioner Lee opposed the motion. Motion Carried.

OTHER BUSINESS

Commissioner Murinko brought up staff evaluations. Commissioners Morton and Lee agreed to take the lead on working on the evaluation protocol for the Executive Director's upcoming evaluation. Tanya Calahan will provide the previous protocol developed by the Commissioners to Commissioners Morton and Lee.

Commissioners and staff spoke about other monthly activities. Tanya Calahan reported working on public records training and projects. Idolina Reta participated in an outreach event regarding race discrimination. Commissioner Strong spoke about outreach she conducted at Everett High School. She also reported that she will be a guest blogger on Huffingtonpost.
