### MINUTES

#### ATTENDANCE

**Commissioners:** Yvonne Lopez-Morton, Commission Chair; Deborah Lee; Charlene Strong; and Vanessa Gaston. A quorum was present.

**Staff:** Sharon Ortiz, Executive Director; Tanya Calahan, Executive Assistant to the Commissioners; Nick Aaseby, Fiscal Analyst; and Heather Polz, Assistant Attorney General.

#### OPENING AND WELCOME

Commissioner Lopez-Morton called the meeting to order at 9:05 a.m.

#### MINUTES

Commissioner Lee made a motion to approve the May 27, 2011 minutes. Commissioner Strong seconded the motion. Motion Carried. The Commissioners agreed to set aside approval of the June 24, 2011 minutes so a quorum of Commissioners who were present at that meeting can vote on them.

#### ACTION ITEM REVIEW

Tanya Calahan provided a copy of the Commissioners attendance record for 2011, the Commission Attendance Policy, and Policy on Official Business to Commissioner Lopez-Morton.

#### CASE CLOSURES

Commissioner Lee made a motion to approve case closures for the month. Commissioner Strong seconded the motion. Motion Carried.

Sharon Ortiz commended the housing team for closing 124 cases during the current fiscal year.

The Commissioners discussed whether or not to have staff continue to send them findings for all cases including administrative closures with no findings of fact. The Commissioners directed that staff send them case closures for all cases unless they direct

otherwise regardless of recommendation. This item will be revisited when more Commissioners are present.

### **AGENCY REPORT**

Sharon Ortiz highlighted staff activities for July 2011 and provided an overview of the agency's monthly report. She reported on the June 28, 2011 all staff meeting and training session that was held at The Evergreen State College. Ms. Ortiz also spoke about position recruitments, outreach activities, and the agency's budget.

### **OLD BUSINESS**

Discussions regarding the remaining meeting schedule, rulemaking, Executive Director evaluation, case closure reporting process, and Commissioners budget will remain standing agenda items until discussed.

The Commissioners briefly discussed the Executive Director evaluation. Commissioners Lopez-Morton and Lee will come up with a timeline for the evaluation. Tanya Calahan will provide a copy of the most recent job description to Commissioners Lee and Morton. There is no updated job description or written expectations for the current Executive Director.

### **NEW BUSINESS**

Sharon Ortiz spoke about an upcoming public event in Vancouver called "Suits and a Keg" which could be potentially discriminatory. The event is advertised "for men only."

Ms. Ortiz and the Commissioners discussed whether or not to formally look into the matter or initiate a complaint. After discussion, the Commissioners asked Ms. Ortiz to contact the organizer of the event and obtain more specific information about the situation and report her findings at the next Commission meeting.
